# CAMP STAFF

## Brie Brenner

Brie Brenner will be entering her second season this fall as head coach of Defiance College volleyball. Brenner is a Defiance, Ohio native and was a two-time Western Buckeye League Player of the Year, while also earning First-Team All-Ohio honors in 2001 for Defiance High.

Brenner began a collegiate career at Ohio State University. Transferring to the University of Washington for her final three seasons, Brenner became a two-time All-PAC-10 performer and led the huskies to a pair of PAC-10 Championships.

The success continued on the national stage, where Brenner and UW advanced to the NCAA Division I Final Four in 2004 and 2005 and claimed the NCAA Division I National Championship in 2005.

Assisting Coach Brenner is former Defiance College standout Jessica Tietje. The Jackets qualified for the Heartland Collegiate Athletic Conference Tournament three of the four seasons that the Deshler, Ohio native was on the team. During her senior season, Tietje was second on the team in kills and third in aces.
